DECISION

(for the transfer of own source revenues from 2017 to 2018)

I. By this decision is approved the request from the Directorate of Budget and Finance for the transfer of unused own source revenues from the year 2017 to 2018, in the amount of **38,528.78 €** as follows:

- The amount of **38,528.78 €** is to be transferred to the category of economic capital expenditures, in code 46030 for the project **Co-financing of projects**, in the Economic Development Program with code 480, under the Economic Development Planning Program, code 48020.

DECISION

For the formation of the Policy and Finance Committee

I. By this decision, the Assembly establishes the Committee on Policy and Finance as a permanent committee in the Municipality of Junik and determines its structure.

II. Based on the Law on Local Self-Government (LLSG) No. 03/L-040, Article 52.1, Policy and Finance Committee is chaired by the Chairperson of the Assembly.

III. The Policy and Finance Committee will have the following composition:

4. Tahir Isufaj - members, political subject LDK,

IV. The Policy and Finance Committee is responsible for reviewing all policies, fiscal and financial documents, plans and initiatives including strategic planning documents, the Mid-Term Budgetary Framework, the Annual Procurement Plan, the Annual Tax Regulation, Tariffs and Payments, the Annual Internal Audit Plan, Mid-Term Annual Budget, and any budget changes for the fiscal year, as well as receiving reports from the Mayor and submitting recommendations to the Municipal Assembly.

V. This decision shall enter into force immediately after signature by the Chairperson of the Assembly.

Based on the Law on Local Self-Government (LLSG) No. 03/L-040, article 12, paragraph 12.2, Statute of the Municipality of Junik, (date: 29.09.2010), Article 21, paragraph 21.1, point j) Municipal Assembly of Junik, at its regular meeting held on date: 30.03.2018, made this:

DECISION

for starting the drafting of (draft) Regulation on amending and supplementing the regulation on municipal taxes, charges and fines

I. With this decision starts the drafting of (draft) Regulation on amending and supplementing the regulation for municipal taxes, charges and fines / in further text (draft) Regulation.

II. The purpose of issuing and approving this (draft) Regulation, according to this decision is to establish the legal basis for starting the amendment and supplementing of the Regulation on municipal taxes, charges and fines.

III. The holder of the (draft) Regulation from point I of this decision is the Directorate for Budget and Finances of Junik Municipality.

IV. The holder of the (draft) Regulation is obliged to draft the (draft) Regulation within 6 months from the day of entry into force of this decision.

V. The Mayor of Junik is authorized after the entry into force of this decision to appoint a working group for drafting of the (draft) Regulation from point I of this decision.

VI. The (draft) Regulation should be put to public scrutiny. Submission of the (draft) Regulation to the public scrutiny and time for submitting reviews and comments will be announced on the website of the Municipality of Junik.

VII. After drafting, the (draft) Regulation is proceeded to the Municipal Assembly for review and approval.

VIII. The financial means for drafting the (draft) Regulation are provided by the budget of the Municipality of Junik.

IX. Upon the entry into force of this decision, all legal provisions by which this field has been regulated are abrogated.

X. The Mayor, respectively the Directorate for Budget and Finance, is responsible for implementing this decision.

XI. This decision enters into force 15 days after the registration in the Protocol's Office of the ministry responsible for local self-government, as well as publication in the official languages on the official website of the Municipality of Junik.
