Based on the Law on Local Self-Government (LLSG), No. 03/L-040, Article 53, Statute of the Municipality of Junik (dated 29.9.2010), Articles 36 and 38, Municipal Assembly in Junik at its regular meeting held on 30.03.2018, issued the following:

DECISION

For the establishment of the Communities Committee

I. By this decision the Assembly establishes the Communities Committee as a permanent committee in the Municipality of Junik and determines its structure.

II. Based on the Administrative Instruction (MALG) on the procedure of establishment, composition and the competences of permanent committees in the Municipality, Article 10, paragraph 2, the Chairperson of the Communities Committee shall be elected by a majority vote of the members of the Committee.

III. The Communities Committee will have the following composition:

1. Xhemë Tofaj - member, political entity AAK - PDK,
2. Kreshnik Maloku - member, political entity AAK - PDK,
3. Zeqë Hebibi - member, political entity LDK,
4. Zenel Maloku - member, independent candidate,
5. Drita Salihu - Hoxha - member, political entity LVV.

IV. The Communities Committee is responsible for reviewing the compliance of municipal authorities with the applicable law and reviewing all municipal policies, practices and activities to ensure that the rights and interests of communities are fully respected. The Committee also recommends to the Municipal Assembly the measures to be taken to ensure the implementation of provisions relating to the need of communities to advance, express, protect and develop their ethnic, cultural, religious and linguistic identities, and to ensure adequate protection of community rights within the Municipality.

V. This decision enters into force 15 days after the enrollment in the Protocol's Office of the ministry responsible for local self-government, as well as publication in official languages on the official website of the Municipality of Junik.

Based on the Law on Local Self-Government (LLSG) No. 03 / L-040, Article 12 paragraph 12.2 d), Statute of Junik Municipality (dated 29.9.2010), Article 22 paragraph 22.1 point 4, Municipal Assembly in Junik at its regular meeting held on 30.03.2018, made this:

DECISION

for the establishment of a Commission for Naming Public Circulation Areas

- I. With this decision is established the Commission for Naming the Public Circulation Areas in the Municipality of Junik.
- II. The term "public circulation area" means the part of the public territory such as boulevards, streets, alleys, squares, parks and road rings.
- III. For the performance of the work of the commission, the same drafts: work plan, work regulation and work report.
- IV. All project documents from point III of this decision are processed by the Municipal Assembly for review and approval.
- V. The work's Project- plan of the commission should be processed to the Municipal Assembly for review and approval no later than 30 days after the commission has been established.
- VI. The commission consists of seven (7) members. One (1) member from each political entity represented in the Municipal Assembly and one (1) independent member, and two (2) members from the executive of the Municipality.
- VII. Proposals from point VI of this decision should be made to the Chairperson of the Municipal Assembly at least 30 days from the day of signing this decision.
- VIII. The commission is an advisory body, while for its work it is responsible to the Municipal Assembly.
- IX. Committee meetings are chaired by the Chairperson of the Commission who will be elected at the inaugural meeting of the commission.

X. The Chairperson of the Commission is elected according to Article 8, paragraph 8.7 of the Regulation on the Work of the Committees of the Municipal Assembly of Junik.

XI. This decision enters into force 15 days after the enrollment in the Protocol's Office of the ministry responsible for local self-government, as well as publication in official languages on the official website of the Municipality of Junik.
