DECISION

FOR AMENDMENT AND COMPLETION OF THE MUNICIPAL STATUTE OF KAMENICA 01 no. 005/2008

KAMENICË, MAY 2010

Pursuant to Article 12.2, 12.3 of the Law on Local Self Government no. 03 / L-040, (Official Gazette of the Republic of Kosovo, No. 28 of 04 June 2008), Article 5.2, 6 of the Law on Administrative Municipal Boundaries, no. 03 / L-041 and Article 15.1 (a) of the Statute of the Municipality of Kamenica, 01 no. 005 dated 26.09.2008, the Municipal Assembly in the meeting held on 31.05.2010, adopted this

DECISION

ON AMENDING AND COMPLETING THE MUNICIPAL STATUTE

OF KAMENICA 01 no. 005/2008

Article 1

Article 16.1 of the Statute is amended as follows:

1.1 Cadastral Code 10 removes settlements according to ordinal numbers; 4, 13, 14, 16, 25, 30, 31, 50, 53, 54, 57, 58, 68 and form the cadastral code 35, while Settlements with ordinal numbers; 3, 6, 8, 45 and 67 are attached to cadastral code 14.

1.2 The municipality of Kamenica consists of villages, settlements and urban neighborhoods, which extend to these cadastral zones:

1.3 Article 16.2 of the Municipal Statute 01. no. 005/2008 is deleted.

Article 2

Article 18.3, the naming of the municipal offices is removed, and is settled in the civil status office:

- a) The civil status office in Muqiverc
- b) The civil status office in Hogosht

Article 18.4, the naming of the municipal offices is removed, and is settled in the civil status office of municipality.

Article 3

Article 19, the naming of municipal office is removed, and is settled in the civil status office.

Article 4

Article 57.2. of the Statute, the Committee also added,

- f) Committee on gender and youth issues

Article 5

Article 74 is added to these paragraphs:

74.3 in order to establish a greater operational efficiency, a major budget and fiscal discipline, Kamenica Municipality based on the Law on Internal Audit no. 03 / L-128, establishes a committee for internal audit.

74.4 The Director of the Internal Audit Unit within the municipal area shall be elected in accordance with the legislation on civil servants and on internal auditing.

74.5 The rights, duties and responsibilities of the Audit Committee and the Director of Internal Audit Unit are regulated in accordance with the Law on Internal Audit no. 03 / L-128.

Article 6

Article 84.2 of the status has been changed and made:

Based on the proposal of the mayor of the commune, the communal assembly forms the following directorates:

- a) Department of General Administration
- b) Department of Education
- c) Department of Economy, Finance and Development
- d) Department of Urban planning and spatial planning
- e) Department of Property, Cadastre and Geodesy
- f) Department of Health and Social Welfare
- g) Department of Public Services and the Environment
- h) Department of Culture, Youth and Sport
- i) Department of Protection and Salvation
- j) Department of Agriculture, Forestry and Rural Development
- k) Department of Inspectorate

Article7

Amendments and amendments to the statute come into force on the date of adoption by the municipal assembly, and its signature by the chairperson of the communal assembly.

Article8

Other provisions of the Municipal Statute of Kamenica 01 no. 005 adopted on 26.09.2008 remain in force.

Article9

With the approval of changes and amendments to the statute, all other municipal acts within three months should be harmonized with the same.
